- 3. The Licensee shall not incorporate any part of the CASINO source code into any other software or modify the CASINO source code without prior written permission of the Authors. The Licensee shall not (itself or through an agent), disassemble, reverse engineer, decompile, or translate the CASINO source code, create derivative works based on the whole of or any part of it, or otherwise adapt or transmit the CASINO software in whole or in part in any manner whatsoever.
- 4. The CASINO software is provided "As Is" and no warranty, condition, undertaking or term, express or implied, statutory or otherwise, as to the condition, performance, satisfactory quality or fitness for purpose of the CASINO software is given or assumed by the Authors and all such warranties, conditions, undertakings and terms are hereby excluded.
- 5. The Authors shall not be liable for any damages or expenses of whatsoever nature and howsoever arising (including without limitation in contract, tort, negligence or for breach of statutory duty or misrepresentation) in connection with any use of the CASINO software or otherwise in connection with this Agreement or any relationships established by it. Without prejudice to the generality of the foregoing, in the event that the Authors should be found liable, then its aggregate liability for direct damages shall be limited to any payment made by the Licensee and excluded in full if no payment was made and none shall be liable for any economic loss (including without limitation loss of profits, revenue, or business opportunity), loss of goodwill, data loss, business disruption, computer failure or indirect, incidental, consequential or special damage.
